THE Terms and Conditions for SHORE

Website-

1. Acceptance of Terms

By accessing or using the SHORE website, you agree to be bound by these Terms and Conditions. If you do not agree to any part of these terms, you must immediately discontinue using the website.

2. Eligibility

Access to specific features, such as event registration and pass purchases, is restricted to GITAM (Deemed to be University) students, faculty, and staff.

Non-GITAM participants may engage in designated activities, provided they fulfill additional requirements such as presenting valid college ID cards.

3. Event Registration and Pass Purchase

Event passes are sold exclusively through the SHORE website. Each pass will feature a unique QR code for event access. Once scanned, the QR code becomes invalid and cannot be reused.

Users are responsible for safeguarding their passes from duplication or unauthorized sharing online.

4. Website Usage

Users are prohibited from exploiting the SHORE website for any unauthorized or commercial purposes, including reselling or counterfeiting passes. Violations will result in denial of access, legal action, or both.

- Event passes are considered confirmed only upon successful payment processing.
